- III. **Roll Call** Michael Green, Paige Feibelman, Tammy Ebert, Carol Gudauskas and Shawanda Thomas were present. Minutes were recorded by Paige.
- IV. **Approval of Minutes** Minutes from the February 6, 2015 meeting were approved pending the correction of two typos.

V. Reports

a. President - Shawanda Thomas

- i. Shawanda reported that she is working on the conference PowerPoint presentation. She is editing the PowerPoint used by Calvin Briggs during last year's conference. Shawanda asked Michael to email her a copy of the conference program with photos to be used in the PowerPoint. Tammy will send Michael a better picture of the Faulkner State Campus.
- ii. Shawanda is preparing an agenda for the annual AlaMATYC Business Meeting. Shawanda will preside at the business meeting.
